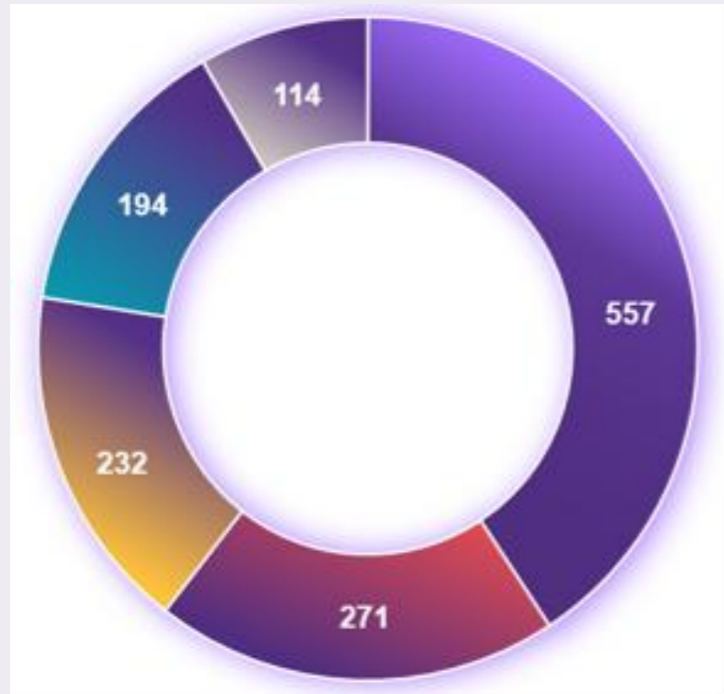

**Κύρια σημεία της Υπουργικής Απόφασης αριθ. 113169/2023**

Εκδόθηκε πρόσφατα η αριθ. 113169/2023 Απόφαση του Υπουργού Εργασίας και Κοινωνικής Ασφάλισης (ΦΕΚ Β 7421/28.12.2023).

Η εν λόγω Υπουργική Απόφαση είναι εφαρμοστική αρχικών διατάξεων του προφορού Ν. 5053/2023, και περιλαμβάνει σημαντικές και ενδιαφέρουσες ρυθμίσεις.

Συγκεκριμένα, προβλέπεται η άμεση, από 1-1-2024 επέκταση εφαρμογής της ψηφιακής κάρτας εργασίας σε επιχειρήσεις με κύρια δραστηριότητα σε κλάδους της βιομηχανίας (αφορά τους ΚΑΔ με πρώτα δύο ψηφία από 10 έως και 33 πλην του 19) και του λιανικού εμπόρου (εντάσσονται έτσι οι ΚΑΔ με πρώτα δύο ψηφία το 47). Προβλέπεται παράλληλα σύντομη περίοδος «κρίσης» περίπου 3-4 μηνών κατά περίπτωση, κατά την οποία δεν θα επιβάλλονται τα ιδιαίτερα αυστηρά πρόσημα που προβλέπονται σε περίπτωση παράβασης των σχετικών με την ψηφιακή κάρτα υποχρεώσεων.

**Fintech**  
BIS published a report which reviews the key elements of the crypto ecosystem.

**Insurance**  
EIOPA launched a survey on access to cyber insurance by SMEs and published a Staff Paper exploring the reasons for the limited uptake of NatCat insurance in Europe.

**MIFID II**  
ESMA highlighted areas for improvement in firms' disclosure of cost and charges under MIFID.

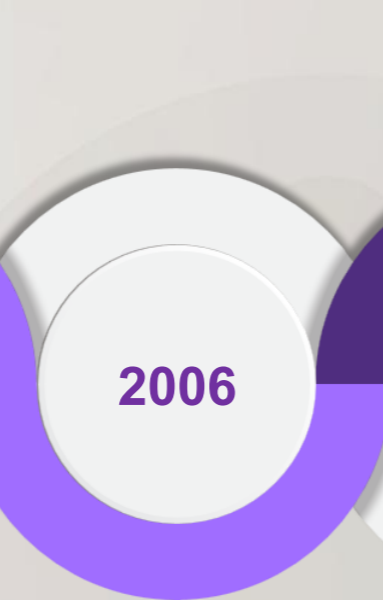
